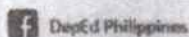

I. 2023 Accomplishment of the Regions

A. Plenary Session

1. Each region shall prepare its 2023 Accomplishment Report which will be presented during the Plenary Session.
2. The 2023 Accomplishment Report shall include, but not be limited to, programs, projects, and activities on the implementation of the Alternative Learning System initiated by the regions and their respective division offices.
3. The report should be in a powerpoint presentation not to exceed five (5) slides using the provided template.
4. Each region will be given 15 minutes to present the 2023 Accomplishment Reports.
5. The Regional ALS Focal Person shall submit to BAE the softcopy of the regional report during the registration on January 16, 2024.

II. Sharing of Best Practices (Break-out Sessions)

1. Each region will be given a chance to share its **best practices** in all of the topics with the requirements given below.
