
Warmest Greetings!

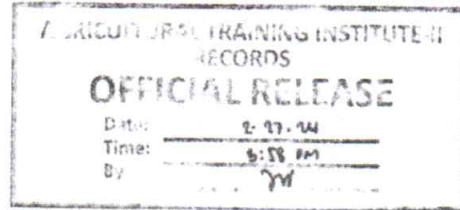
