

VARIETY SHOW CONTEST

GENERAL GUIDELINES AND MECHANICS:

- Performers must be bonafide residents of Panabo City;
- The performers must be a current member or employed of the following: (ABC, DepEd; Cooperatives; LGBTQIA2S+; Uniformed Personnel e.g. PNP, AFP, BFP etc.; Peoples Organizations or CSOs, etc.);
- 3. Performance must have a minimum of five (5) minutes and a maximum of seven (7) minutes will be allowed for the preparation;
- 4. A minimum of ten (10) and maximum of twenty (20) members per participating group with no gender bias:
- One point shall be deducted from every judge's score for every 10 seconds in excess of the allotted maximum time;
- 6. In case of a tie, point system will be applied. In case of a further tie, the Chairman of the Board of Judges will break the tie;
- 7. Music should submit their tapes, CDs or flash drives to the committee in-charge;
- 8. Vulgar words/terms and incident gestures are not allowed. The attire must justify the chosen variety show concept;
- Using of fire & live animals or other deadly props is strictly prohibited. Disqualification is strongly implemented if the participants violates;
- 10. Any Props and Costumes are allowed except those which are offensive. And, removing pieces of clothing during the performance is permitted provided it is not offensive or out of character;
- 11. The performers may showcase a dance number, song number, play, or a combination of talents etc.;
- 12. No one is allowed to perform in the presence of alcoholic drink. If a group member/performer is caught, the group will be automatically disqualified;
- 13. Variety Show is designed so that any group can do anything, such as but not limited to comedy, drama, music, dance, or other (so long as it is deemed appropriate);
- 14. The variety show contest will be accepting TEN (10) participating Group performers from different sectors. All sectors are encourage to join the said contest and appoint one group performers;
- 15. The decision of judges will be considered final and not subject complaint or alteration.
