Please be informed of the deadline of facilitating the resolution of LIS pending issues is extended on March 22, 2024. The following instructions are to be observed for proper facilitation, to wit:

- 1. LRN Approval for learners with no Learner Reference Number, the school shall submit a request for LRN approval to the Division Office with support documents
- 2. Correction of Learner Profile and Grade Level for corrections, the school shall email the supporting documents for the said request
- 3. Enrollment of Ineligible and Enrollment with Gap the school shall email the SF10 or SF9 of the concerned learner from his/her previous school/grade level
- 4. Temporary Enrollment the school shall email the Affidavit of Undertaking accomplished by the parent/guardian of the learner
- 5. Pending Transfer-out the school shall confirm the transfer-out requests
- 6. Pending Transfer-in the school shall contact the previous school for the confirmation of the transfer
- 7. System Errors the school shall accomplish the applicable Request for Correction Form (RFC)
