- b. the conduct of this activity shall be subject to the no-disruption-of classes policy stipulated in DepEd Order (DO) No. 9, s. 2005 titled "Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith":
- c. DO No. 34, s. 2022 for strict compliance of this school year's school calendar to comply with the required number of school days to attain the learning standards;
- d. DepEd Order No. 49, s. 2009 "Reiterating the Revised Rules and Regulations on the Teaching of Religion in Public Elementary and Secondary Schools" specifically on the requests for religious instruction by parents and other proper authorization paper for optional religious instruction; and
- e. **no-collection policy** as stated in Section 3 of Republic Act No. 5546 also known as an Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities (Ganzon Law).
