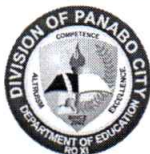

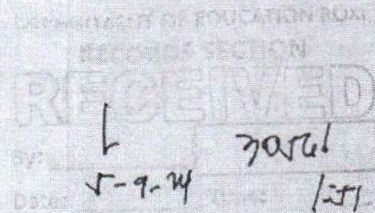

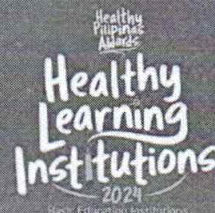

CALL FOR ENTRIES!



Who can participate?

All PUBLIC and PRIVATE grade schools and high schools in **Davao Region**.

Application procedure:

- **One application per campus.** Schools with separate elementary and secondary campuses can submit separate application.
- Interested schools **must fill out the online registration form** providing contact details of an authorized representative.
- Indicate chosen award category in registration form. **Schools can apply for multiple categories if eligible.**
- For Last Mile Elementary Schools (LMEs) category, submit the **completed Self-Appraisal Checklist (SAC) and Activity Report on or before June 15, 2024.**
- For public and private elementary and high schools, submit the **completed Self-Appraisal Checklist (SAC) on or before June 15, 2024.**
- For best practices, submit original health promotion projects or programs implemented between 2022-2023 within your jurisdiction. Entries outside this period are not eligible.
- Application must not include unauthorized third-party materials or inappropriate content including anything offensive, defamatory, or in breach of confidentiality.





Award Categories for the Regional Awarding

Healthy Schools Category

Public or private grade schools and high schools that meet the standards of HLI.



Satisfactory

The school meets 65%-80% of standards in all pillars



Very Satisfactory

The school meets 81%-95% of standards in all pillars



Outstanding

The school meets 96%-100% of standards in all pillars



Best Practices Awards

Projects, activities, or programs under 6 pillars of a Health-Promoting Schools Framework

Last Mile Category

Last Mile Elementary (LMEs) and High Schools (LMHs) with outstanding health promotion efforts led by active community members



Outstanding Last Mile School

Scoring shall be based on the school's HLI activity report.



Outstanding Last Mile HLI Champions

Individuals who strongly advocate for health promotion, working to transform their schools into healthy learning institutions
