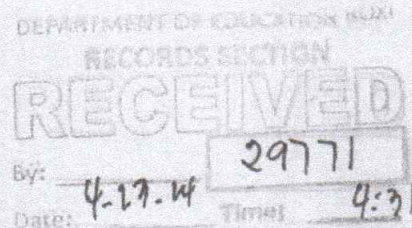

Greetings and well wishes from Colombo Plan!

The Colombo Plan - Drug Advisory Program (DAP), with support from the Bureau of International Narcotics and Law Enforcement Affairs (INL), US Department of State in Manila will be conducting one of the project components of Improving Drug Use Prevention Climate in the Philippine Classrooms with the Department of Education to increase the accessibility of the Universal Prevention Curriculum to schools across regions. The last phase of the project is the rollout of the Universal Prevention Curriculum Managers and Supervisors Course 5: School-based Prevention Interventions to 17 regions in the country.
