Attached is a letter from the Department of Health – Davao Center for Health Development dated June 25, 2024, which is self-explanatory.

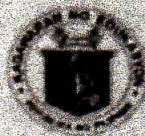

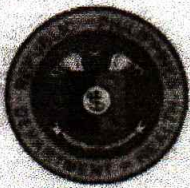
