The Department of Education (DepEd), through the Bureau of Learning Delivery (BLD)- Indigenous Peoples Education Office (IPsEO) will be conducting the **Validation Workshop of Nationally Consolidated Cultural Standards and Its Integration in DepEd Policies** on **August 12 to 16, 2024 (inclusive of travel time)** at the **National Educators Academy of the Philippines (NEAP) – National Capital Region (NCR), Cepeda St., Marikina City**.

This workshop aims to consolidate and validate at the national level the locally generated cultural standards developed with Indigenous Peoples (IP) communities involved in IPEd implementation over the past ten years. The nationally consolidated

cultural standards can then be used as a reference in enhancing DepEd policies to be more inclusive of the context, views, and aspirations of IP communities.

As a pre-work to the workshop, all Regional IPed focal persons are requested to collect all division cultural standards that have been generated over the past six to seven years. These will be the main content and basis of the validation workshop.

Participants are expected to arrive on August 12, 2024, and depart on August 17, 2024. Please see *Enclosure 1* for the list of participants and *Enclosure 2* for the Activity Design. They are advised to bring their laptops and extension cords.

Food and accommodation expenses shall be charged to the DepEd Central Office - IPed Program Support Fund while travel expenses of participants shall be charged against local IPed Program Support Funds, subject to availability and the usual government accounting and auditing rules and regulations. Participants are encouraged to avail of the most economical means of transportation in going to and from the venue.

Airfare of participants from the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) shall be shouldered by IPsEO and charged to the funds for this activity (AC-24-IPsEO-IPed-P011), while local travel (land and ferry) shall be charged to local funds, subject to availability and the usual accounting and auditing rules and regulations (including accommodation expenses in case when the participants arrive earlier/leave later than specified in the official schedule of the activity due to the availability of flights/trips to and from the venue). A copy of the signed travel authority shall be submitted to the activity secretariat by BARMM participants.
