Dear **Mr. Ocampo**:


This pertains to the letter of Ms. Linda Flor P.D. Hortezano, CSBI Relationship Management Executive, requesting approval to offer and grant calamity loans to DepEd personnel for the areas declared in a state of calamity due to Super Typhoon Carina.

Pursuant to Paragraph 3.9, Enclosure 1 of DepEd Order No. 20, s. 2021, "Except for existing loans at the time of execution of this TCAA, the Lender is authorized to grant only one (1) new loan per Borrower for inclusion in the APDS. However, the Lender may grant additional loan to Borrowers in the event there is a declaration of state of calamity in the particular province/s, subject to NTHP verification". In view of the aforementioned provision, the said request is hereby approved, subject to the following conditions:

1. The additional loan shall only be granted to the affected DepEd regular employees whose residences were declared under a state of calamity;
2. The granting of the said loan shall only be within the provinces where your entity is allowed to utilize the Automatic Payroll Deduction System (APDS) facility;
3. Availment of additional loan shall only be available within three (3) months after the declaration of state of calamity;
4. The loans that will be processed for the purpose shall be subject to the usual verification process by the designated DepEd Verifiers on the resulting Net Take Home Pay (NTHP). Copy of the declaration of state of calamity must be attached to the loan application; and
5. All other conditions stipulated in the TCAA, especially the Interest Rate and Other Charges (which could be reduced by CSBI) shall remain enforced and effective.

Please be guided accordingly. Thank you.
