In view thereof, compliance to National Budget Circular 563 dated April 22, 2016, is hereby directed, no-collection policy as stated in Section 3 of Republic Act No. 5546 also known as An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities (Ganzon Law) and no government funds be used in the abovementioned activity.






