

The Bureau of Alternative Education – Program Management and System Development Division (BAE-PMSDD), will conduct the **Framework and Design Development Workshop for the National ALS Research Studies** from **August 14 to 16, 2024**, at a venue within NCR (specific venue will be announced through a separate notice).

This activity aims to address two specific research gaps identified in the Research Agenda 2022-2026, focusing on the areas of quality and access. The first gap will be investigated through study on the effectiveness of the 4As Approach as an instructional model in the Alternative Learning System (ALS) program. The second gap will be explored through a study on the possible expansion of ALS programs.
