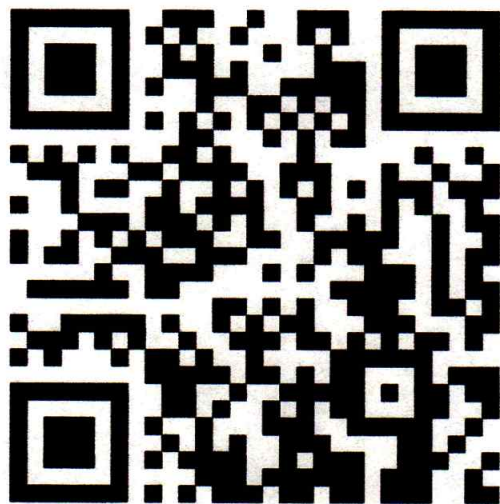

CWM REGIONAL QUIZ BEE

Guidelines and Mechanics

Guidelines

1. The Quiz Bee is open to all junior high students (grades 7- 10) who are presently enrolled in any of the schools (private and public) located in the Davao Region.
2. The participants shall compete by pair (the composition shall be regardless of grade level).
3. The participant must show proof of their enrollment by presenting a school ID or certification from the school that they are enrolled for this school year 2024-2025 and their grade level.
4. Participating schools must register their contestants with the contest secretariat upon arrival at the venue.
5. Each contestant must wear a proper school uniform with a school ID during the contest. In case the student has no uniform, white t-shirt shall suffice.
6. Before the start of the competition proper, the Quiz Master will perform the roll call of all confirmed participants. Participants who have not been called or have failed to confirm with the contest secretariat will not be allowed to join the competition.
7. Family members and relatives of DTI-11 employees (regular & contractual) within the 3rd level of consanguinity or affinity are not allowed to join the contest.
8. A Provincial Level quiz bee shall be conducted, and the top 3 winners shall be qualified for the Regional Level.
9. Regional Level Quiz Bee will be conducted region-wide in Davao City on October 28, 2024. (specific venue shall be announced before the event date)

General Mechanics:

- All contestants will answer the same set of questions in writing.
- Before a question is read, the teams must raise their hands.
- Each question will be read TWICE by the Quiz Master. After the 2nd reading of the question, the Quiz Master shall say "GO" – only then will the team be allowed to write their answer.
- Ten to thirty seconds, depending on the round, is allotted for each question.
- A bell will be rung at the end of the 10 or 15 seconds, and the Quiz Master will say, "TIME IS UP".
- Teams should stop writing, and they shall raise their boards when the Quiz Masters say, "RAISE YOUR ANSWERS".
- Failure to raise the answer board within the time period will forfeit their answer for that question.
- The Quiz Master will announce the correct answer to the question. Assigned moderators will check each contestant's board to determine if the answer is correct.

- Boards will not be lowered unless the Answer has been tallied or recorded or when the team has been called.
- The Quiz Master will perform a roll call for each team and will ask the DTI assigned personnel if the answer is correct or wrong. The points earned will then be flashed on the screen.
- There will be three rounds: **Easy** (10 multiple-choice questions – 1 point each), **Average** (10 questions – 3 points each), **Difficult** (5 questions – 5 points) and **Championship** (5 questions – 1 point)
- The points from the first three rounds are accumulated but for the Championship round, the points shall revert back to zero to place the teams in equal footing.
- A clincher or a sudden death round shall be done in cases where there would be a tie.
- Coaching and cheating are strictly prohibited and shall warrant automatic disqualification.
- The contestants should not bring anything except markers, pens, papers and boards, which DTI will provide.
- Answers should be written in CAPITAL letters for the Multiple choice questions.
- Spelling must be correct, and abbreviations and the use of acronyms will not be allowed.
- There will be no penalty for wrong and no answer.

For the Easy Round: (1 pt)

- There will be 10 questions for the easy round.
- The easy round will be made up of multiple-choice questions answerable within ten (10) seconds.
- The question will be read twice, and the contestants must answer within the time given.
- Participants will not raise or show their answers before the time ends. They will be asked to raise their answers.
- Moderators will check and tally the correct answers. Participants will lower their answers only when the quiz master asks them.

For the Average Round: (3 pts)

- There will be 10 questions for the average round.
- The question will be read twice. They will be given fifteen (15) seconds to answer.
- Participants will not raise or show their answers before the time ends. They will be asked to raise their answers.
- The answers must be clear and legible. Moderators will check if the contestants give the correct answers.

- Moderators will check and tally the correct answers. Participants will lower their answers only when the quiz master asks them.

For the Difficult Round: (5 pts)

- There will be 5 questions for the difficult round.
- The question will be read twice. They will be given fifteen (15) seconds to answer.
- Participants will not raise or show their answers before the time ends. They will be asked to raise their answers.
- Moderators will check and tally the correct answers. Participants will lower their answers only when the quiz master asks them.
- Top 5 pair with the highest point shall proceed to the Championship Round.

In case of a tie on the fifth place:

- A sudden death Round shall be conducted.
- The pair who gets the correct answer will move to the Championship round.

For the Championship Round:

- There will be 5 questions for the Champion round.
- The remaining five teams shall continue to answer five (5) identification questions.
- The question will be read twice. They will be given fifteen (15) seconds to answer.
- Participants will not raise or show their answers before the time ends. They will be asked to raise their answers.
- Moderators will check and tally the correct answers. Participants will lower their answers only when the quiz master asks them.

In case of a tie:

- A sudden death Round shall be conducted.
- The pair who gets the correct answer shall be declared the winner for that rank.

General rules in case of a protest

- The duly registered coach of the contestant is the only person authorized to make a protest.
- All protests should be referred to the moderators immediately before the Quiz Master reads the next question.
- All protests must be backed up with a proof of reference on hand.



General Rules for the Moderators

- The Moderators must uphold all Quiz Bee Rules & Regulations first and foremost.
- The Moderators must not entertain any and all protests after the next question is read.
- The Moderators will entertain no protest without proof of reference on hand.
- A protest is allotted a 2-minute time limit.
- Time starts from the receipt of the protest by the Moderators.
- The Moderator coming from the same province as the protester shall inhibit him/herself.
- The Moderators must make a final decision after the time limit. The final decision must be unanimous among the moderators.
- In case of a deadlock decision, the moderators can nullify a question and replace it with another question. This decision can only be made in extreme cases.
- The Moderators' decision shall be final in all protested questions.
