RESOLUTION NO. 01, SERIES OF 2024

REVISING RESOLUTION NO. 01, SERIES OF 2023

**ENTITLED "APPROVING PRIZES TO THE BARKADA KONTRA DROGA (BKD) OF THE
DEPARTMENT OF EDUCATION INTEGRATING THE IMPLEMENTATION OF THE
STRONG FAMILIES PROGRAM, AND OTHER VARIOUS ACTIVITIES DURING THE
DRUG ABUSE PREVENTION AND CONTROL WEEK CELEBRATION"**

WHEREAS, the Barkada Kontra Drogen (BKD) is an essential program initiated by the Department of Education aimed at preventing drug abuse among students through peer group activities and fostering a drug-free environment;

WHEREAS, the Strong Families Program is a program developed by the United Nations Office of Drugs and Crimes (UNODC) that focuses on strengthening family bonds, promoting effective communication, and enhancing parental involvement to prevent substance abuse and other related issues among the youth;

WHEREAS, the Strong Families Program has been adopted by the Provincial Anti-Drug Abuse Council Resolution No. 02, series of 2021, "Resolution Approving and Adopting the Strong Families Program as a Drug Abuse Prevention Program for Children and Youth of Davao del Norte";

WHEREAS, the integration of the Strong Families Program with the BKD initiatives will further reinforce the objectives of both programs, creating a more comprehensive approach to preventing drug abuse and promoting healthy lifestyles among students and their families;

WHEREAS, recognizing and rewarding the efforts of participating BKD groups will encourage greater participation, dedication, and innovation in implementing these integrated programs effectively;

WHEREAS, the primary objective of this resolution is to acknowledge and reward the exemplary efforts of BKD groups in integrating the Strong Families Program thereby enhancing the overall effectiveness of drug prevention and family strengthening initiatives.

Section 1. Composition of the Audit Committee. The committee shall be formed to evaluate the implementation of the integrated program based on the criteria. The committee shall consist of:

- a. Philippine Drug Enforcement Agency (PDEA)
- b. Davao del Norte Provincial Police Office (DNPO)
- c. Non-profit Organization (NGO) specializing in community development and drug abuse prevention

WHEREAS, evaluation findings and recommendations shall be submitted to the Provincial Anti-Drug Abuse Council (PADAC) thru its secretariat for review and action;

Section 2. Criteria for Selection. The criteria for selecting the awardees shall include:

- a. Functionality of the BKD on Drug Abuse Prevention in Secondary Schools (45 Points)
- b. BKD Laban sa Ilegal ng Droga (Conveying the BIDA Framework (30 points)
- c. Innovations (25 points)

Section 3. Conditions and Prizes. A recognition mechanism shall be established to reward exemplary implementation efforts. Conditions and prizes shall be awarded as follows:

- 3.1. The best overall Barkada Kontra Droga program, as determined by set criteria shall receive a cash prize of Php 25,000 to be given in cash to the school implementer and Php 5,000 Php to the BKD school coordinator.
- 3.2. The remaining three (3) participating schools shall receive a cash prize of Php 15,000 each, with Php 3,000 to be given in cash to each respective BKD school coordinator.

WHEREAS, awards may consist of, but are not limited to, financial grants, certificates of recognition, and other incentives deemed appropriate like educational materials if and when available by the awarding body to other participating schools;

WHEREAS, schools and coordinators shall be responsible for the proper utilization of the funds being awarded towards the enhancement and sustainability of the Barkada Kontra Droga and Strong Families program initiatives within their respective institutions;

Section 4. Implementation and Monitoring. The Provincial Anti-Drug Abuse Council thru its secretariat in collaboration with Department Education and multi-stakeholders, shall oversee the implementation of this resolution. Regular monitoring and evaluation shall be conducted to ensure transparency and effectiveness in awarding the prizes.

WHEREAS, on motion of Ms. Kaye T. Ruiz, Focal Person, Anti-Drug Abuse Program of Island Garden City of Samal and duly seconded by Mr. Roqueus L. Cimafranca, Focal Person of Anti-Drug Abuse Program of Panabo City, approved the allocation and distribution of prizes to outstanding BKD schools' implementers that have successfully integrated the Strong Families Program into their activities;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the Provincial Anti-Drug Abuse Council approves the allocation and distribution of prizes to outstanding BKD groups that have successfully integrated the Strong Families Program into their activities;

RESOLVE FURTHER, this resolution shall take effect immediately upon its approval. Adopted this 20th day of June, 2024.
