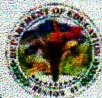

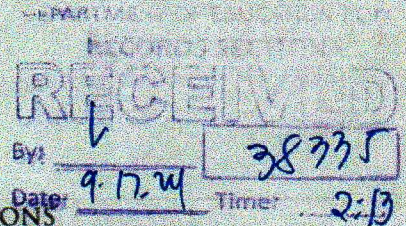

This has reference to the requisite documents for the conduct of the Training on Learner Rights and Protection Committee Functionality-Batch 2.

The Learner Rights and Protection Office (LRPO) was mandated to ensure that all learners in the Philippines are protected from different forms of violence, exploitation, discrimination, bullying, and other conditions prejudicial to their development. Relatedly, the LRPO has been consistently given a budget for the functionality of the Child Protection Committees (CPCs) in schools.

Further, based on the findings of the Programme for International Student Assessment (PISA) in 2018 and 2022, 65% and one out of three Filipino students were bullied, respectively. Meanwhile, based on the data of the Learners TeleSafe Contact Center Helpline, bullying is the 2nd most reported learner protection incident.

The Training on Learner Rights and Protection Committee Functionality-Batch 2 shall have the following objectives:

- Identify and understand their roles in handling bullying incidents;
- Develop intervention programs for bullying incidents;
- Conduct mindfulness activities for learners involved in bullying;
- Proper handling of learners involved in bullying- the bully, the victim, and the bystanders;

- Refer severe incidences of bullying to the Local Social Welfare and Development Offices; and
- Enforce a rights-based approach to bullying.

The Training shall commence on October 7-11, 2024 at Ecotech Center, Lahug, Cebu City. Participants are expected to check in at the venue on October 7, 2024, Monday, at 2:00 PM, and should check out on October 11, 2024, Friday, at 12:00 NN.

The desired participants shall charge their travel expenses to the local funds or the appropriate downloaded funds¹ of the LRPO to the Regional Offices, subject to government accounting and auditing rules and regulations.
