Section 9 of the Implementing Rules and Regulations (IRR) of Republic Act No. 11510, or "An Act Institutionalizing the Alternative Learning System in the Basic Education for Out-of-School Children in Special Cases and Adults, and Appropriating Funds Therefor," mandates the Bureau of Alternative Education (BAE) to establish appropriate communication and coordination channels and implementation mechanisms between the DepEd Central Office and field offices for the planning, implementation, monitoring and evaluation of Alternative Learning System (ALS) programs.
