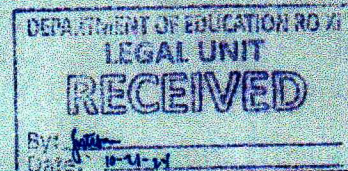

In line with our ongoing collaboration with the Department of Environment and Natural Resources (DENR) on the application and issuance of special patents and presidential proclamations for untitled public school sites, the Sites Titling Office (STO) under Office of the Undersecretary for Legal and Legislative Affairs will conduct an interface activity with the DENR for the joint assessment and planning on school sites titling. The activity will be held within National Capital Region on **November 12-15, 2024** at a venue to be announced later.

This activity aims to assess the implementation of the previous Memorandum of Agreement (MOA) between DepEd and DENR and to collaboratively address bottlenecks and other issues encountered during the application and processing of special patents. It also aims to ensure smooth coordination between our agencies for the implementation of the fourth (4th) MOA, which is expected to be signed before the end of the year.

In this regard, each Regional Office and Division Office is directed to send a representative to the activity, who are in-charge in facilitating the titling of public school sites. The representatives from the regional and division offices must be
