Date: **November 18, 2024**

Please be informed that our Christmas Tree Lighting Contest will commence this November 2024 and will be judged during our Kahayag sa DepEd 2024 Festival this December 2, 2024.

Each building and its partner schools from their respective districts shall represent one (1) entry, as specified in the Division Memo SGOD 2024-0552. Christmas Trees shall be built not later than November 29, 2024.

Below are the guidelines and mechanics of the contest.

Christmas Tree Specifications

- a. Must be 7-10 feet in height.
- b. Must be 80% made of indigenous or recyclable materials,
- c. Must have a creative and festive lighting scheme.

Criteria:

1. Creativity and Originality (40%)
(Unique Design and Concept, Innovative Use of Materials)
2. Adherence to Theme and Use of Indigenous/Recyclable materials, and craftsmanship (30%)
(Alignment with the overall Christmas Theme with incorporation of traditional or modern Christmas elements)
3. Festive Appeal and Lighting (30%)
(Visual Impact and Overall Aesthetic)

Winners will be announced on the same day and Judge's decision is final and irrevocable.
