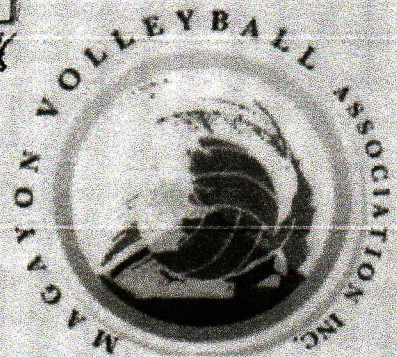
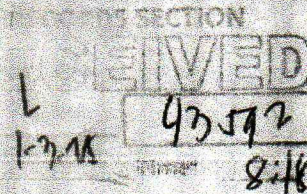

Attached herewith is the letter and poster for the upcoming PNVF National Referee Candidate. Again, kindly **ALLOW** our Bicolano Teachers to attend at least their School Sport Coordinator, Volleyball Coach or P.E. Teachers

The Philippine National Volleyball Federation (PNVF) in partnership with the Magayon Volleyball Association Inc., is coming back to Legazpi and will be holding the 6-days PNVF NATIONAL REFEREE & Refresher Course for Volleyball Officiating and Rules of the Game on January 14-19, in Legazpi City, Albay (BICOL).

Specific course Objectives

- a. This course transcends mere educational opportunity – it signifies a stride towards excellence of the Sports Development Program. Specifically, it Integrated Educational and Skill Training that is aimed at cultivating a dynamic and comprehensive approach to sports education and development.
- b. This course aims to unify interpretation of rules, correct adoption system, emphasize on exact and proper mechanics, continue to promote volleyball as a sport, and develop the young, new breed of dynamic volleyball referees.
- c. This ensures teachers keep pace with the current standards of PNVF, keeps their knowledge and skills current so they can deliver high-quality teaching and impact positively on student and student-athletes' outcomes. It makes sure that they become more effective in carrying out teacher-Referee responsibilities during every volleyball competition, especially the Regional Meet and Palarong Pambansa.
- d. A knowledgeable referee is crucial to a sport as they ensure fair play by accurately applying rules, identifying dangerous situations, and maintaining a safe environment for athletes, allowing them to focus on their performance while minimizing the risk of injury and fostering a positive competitive spirit.

**** This program allows educators to learn about new teaching methods which improve their teaching practice. Educators can improve their teaching practice and better meet the needs of their students by expanding their knowledge and skills. Specially, DepEd Teachers are also given the responsibility of Refereeing during the Regional Meet and Palarong Pambansu, this will help them understand and coach the student-athletes better and effectively.*

We are also inviting DepEd/CHED personnel (coaches, trainers and school P.E. teachers) and other private organizations/clubs who want to upgrade and refresh their knowledge of the rules of the game since volleyball rules & regulations update almost every year. In fact, a new set of rules is to be implemented next year and will be used in all local and international tournaments.

This NRC program can be used for the teacher's CPD's point, to measure their educational activities and can be used to maintain professional registration and as evidence of their commitment to continued professional development.

Participants who pass the refereeing standards will be given **accreditation as National Referee Candidates (NRC)** on their proficiency (results on written, oral and practical examinations) at the end of the course. The names of those who will pass **will be submitted to the PNVF Referee and Rules of the Game Commission (PNVFRRGC) and the FIVB Referee Candidate computerized list.** From then on, these referees will form part of the Bicol-based referee corps who will be tapped to officiate in any PNV and PSC sanctioned tournaments nationwide.

The PNV accreditation is also a step towards becoming an International Referee (IR) and the chance to officiate in international volleyball competitions.

A registration fee of Five Thousand Five Hundred Pesos (**Php 5,500.00**) per participant will be required to cover the cost of the Course, OFFICIAL PNVF National Referee ID, & a polo shirt.

Reservations shall only be allowed upon payment of the registration on a first come first serve basis thirty-five 35 slots in the Bicol Region and additional five (5) per other regions only. If there's more participants, PNVF will add an instructor.

LAST DAY OF REGISTRATION will be on JANUARY 7, 2025

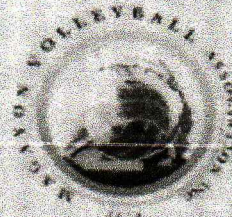
