SUBMISSION OF APPLICATION FOR REGIONAL TOURNAMENT MANAGERS

To: Schools Division Superintendents

1. This Office, through the Education Support Services Division, received some information that a handful of Regional Tournament Managers (TMs) requested to be replaced as TMs due to personal and other reasons.
2. In view of this and to ensure that all TMs who will serve during the 2025 DAVRAA Meet are healthy, fit, resourceful, and highly qualified to perform the tasks, this Office declares all TM positions vacant.
3. Interested applicants are required to submit to the Office of the Regional Director, attention: Dr. Warlito E. Hua, Chief Education Supervisor, the following documents for evaluation:
 - a. **Letter of Intent** to Serve as Regional TM for the Desired Event;
 - b. **Resume** (with latest 2x2 picture);
 - c. **List of Experiences** (with Certificates/MOVs within 6 years);
 - d. Latest **Medical Certificate** (within the last quarter of 2024);
 - e. Latest **Certification of No Pending Criminal/Administrative Case/s**;
 - f. **Recommendation** from the **Assistant Schools Division Superintendent (ASDS)** and **Schools Division Superintendent (SDS)**;
4. Regional TMs who served in the 2024 DAVRAA Meet are encouraged to reapply along with new/aspiring regional TMs. The **deadline for the submission of applications will be on or before January 3, 2025.**
5. A regional Technical Working Group (TWG) will be organized to evaluate applicants. The group will submit the recommended new set of regional Tournament Managers (TMs), to the Regional Director for approval.
6. Immediate and wide dissemination of this Memorandum is required.
