Please use the SALN additional sheet/s for additional information as necessary to keep the prescribed form.
 - 2.1 SALN Additional sheet for the exclusive properties of the declarant's spouse and unmarried children below eighteen (18) years of age living in the declarant's household.
 - 2.2 SALN additional sheet/s for the declarant.

Further, It is requested that all SALN shall be submitted to the SDO-Records Section in bunch original copy (**2 sets**) by the school together with Form A-1, Notarized attachment B-C, and send the Electronic scanned copy of each SALN form saved in PDF format at panabocity.division@deped.gov.ph




