CONSULTATION WITH FIELD AND INDUSTRY PARTNERS ON THE  
PROPOSED SENIOR HIGH SCHOOL CURRICULUM

To: Schools Division Superintendents

1. To streamline the Senior High School Curriculum to better prepare students for the future and igniting full potential, this Office, through the Curriculum and Learning Management Division will conduct consultation caravan through Focus Group Discussion (FGD) with select school heads, teachers, parents and students in both public and private schools, TVI administrators and other stakeholders supportive of the SHS program. The schedule is attached for guidance.
2. Relative to this, Schools division is advised to identify respondents following the number indicated in each category. Names must be submitted through Registration Form attached or encode in the link provided, and print the forms found in <https://tinyurl.com/StrengthenedSHSconsultation> for the respondents to fill out prior to the conduct of the consultation.
3. CLMD and CID Chief Education Supervisors with select RO EPS will serve as FGD moderators during the consultation sessions. SDO will assign personnel as documenter to transcribe participant's responses in each session using the template provided.
4. In compliance with the data privacy act, respondents are requested to comply with the documentary requirements by filling out the Non-Disclosure Agreement (NDA) and the Informed Consent Form (ICF) which will be collected during the consultation day.
5. Food for the participants will be charged to the downloaded funds to the SDOs, while travel and other incidental expenses will be charged to local funds. The food, accommodation, travel and other incidental expenses of the Regional Office personnel shall be charged to the downloaded funds to the Region, in OSEC-11-25-00028, all subject to the usual government accounting and auditing rules and regulations.
6. School heads and teachers should see to it that the activity will not disrupt classes.
7. There shall be no lavish preparations, no tokens, no leis and others that are not directly related to the conduct of the activity.
