JUAN LUNA SYNOPSIS

Isang dulang musikal na naglalaman ng linya o diyologo na pasalita at pakanta. Ang ilan sa mga awitin ay sasamahin din ng sayaw. Sasaliwan naman ng orkestra na tugtog sa mismong pagtatanghal. Tatakbo ang dula ng dalawang oras na maaaring lagyan ng pagitan pagkatapos ng mang yugto. Nagtataglay ito ng tatlong yugto at may higit sa tatlumpung tagpo. Gagampanan ito ng higit sa apatnapung mandudula.

Humikot ang istorya sa buhay at mga obra ni Juan Luna (October 23, 1857 – December 7, 1899), isang pintor, iskultor at rebolusyunaryong Filipino ng mga huling taon ng ika-labing siyam sa siglo. Isa siya sa maituturing na namang Filipino alagad ng sining ng bansa. Ang pagwawagi niya ng gintong medalya sa 1884 Exposición Nacional de Bellas Artes sa Madrid ang naging natatanging sanhi ng isang pagdiriwang at pagtitipon ng mga kasaping Ilustrado ng Propaganda at nagbigay daan sa Rebolusyon laban sa mga Kastila.

Taong 1883 sinimulan ni Luna ang pagpinta na hinilang ng Ayuntamiento. Noong Mayo 1884, inangkat ang malaking kambas na gagamitin sa pagpinta ng Spolarium sa Madrid. At noong Hunyo 25, 1884 pagkatapos ng pagwawagi ni Luna ng gintong medalya para sa eksibisyon, nagtipon ang mga Filipino ng hinirang at nagbigay ng talumpati si Dr. Jose Rizal upang papurihan ang angking galing ni Luna.

Noong Disyembre 8, 1886, nagpakasal si Luna kay Maria de la Paz Pardo de Tavera. Ang mag-asawa ay tumulak sa Venice at Roma bago tuluyang nanirahan sa Paris. Minahal ni Luna ang kanyang asawa at ang sobrang pagmamahal ang nagbunsod sa kanya ng labis na pagseselos at pagdududa. Pinagdudahan ni Luna na nagtataksil ang kanyang asawa at karelasyon ang isang Monsieur Dussaq. At noong Setyembre 22, 1892, dumating ang sukdulan ng kanyang pagseselos at napatay niya ang kanyang asawa at biyenan na babae, at nasugatan ang bayaw na si Felix. Napawalang sala naman si Luna dahil sa depensang krimen de pasion, isang pansamantalang pagkabaliw dahil sa matinding pagseselos.

Sa kanyang mga huling taon, noong taong 1894, bumalik si Luna sa Pilipinas at nataon sa Sigaw ng Pugad Lawin sa Balintawak. At noong Setyembre 1896, inaresto si Juan at ang kanyang kapatid na si Antonio ng mga guardia sibil na Kastila dahil sa kanilang partisipasyon sa Katipunan. Habang nakakulong, nakagawa pa si Luna ng isang obra na ibinigay niya sa isang paring bumisita sa kanya. Binigyan si Luna ng pardon ng hukuman kaya't muling umalis ng bansa at tumulak sa Espanya. Sa kanyang pagbabalik sa Maynila dahil sa pagpatay sa kanyang kapatid na si Antonio noong Disyembre 1899, lubos niyang dinandam ang lahat ng naganap at noong Disyembre 7, 1899 siya ay binawian ng buhay dahil sa isang atake sa puso.

Ang dulang ito ay isang eksperimental at malalim na paghinay at pagsanib ng sining-biswal at pagtatanghal. Sisilipin ang tinay na kahalugan ng kanyang mga obra tulad ng Spolarium at Parisian Life at tila ba mabubuhay sa entablado ang mga likhang ito sa pamamagitan ng teatro. Ito ay isang pambihirang pagkakataon na magsanib pwersa ang napakaraming uri ng sining para sa isang natatanging pagtatanghal.

The PSF aims to provide supplemental learning, such as watching a quality stage presentation that will benefit the students academically, for they focus on the holistic approach in the study of the Filipino language, modern literature, arts appreciation, value formation, and Philippine history.

Learners and teachers from public and private secondary schools are invited to watch the film.

Participation of learners and teachers from public and private schools shall be purely voluntary and will not hamper instructional time in compliance with the provisions of DepEd Order (DO) No. 009, s. 2024 titled Implementing Guidelines on the School Calendar and Activities for the School Year 2024-2025 and DO 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith and the policy on off-campus activities stated in DO 66, s. 2017.

This is also subject to the no collection policy as stated in Section 3 of Republic Act No. 5546 also known as An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities (Ganzon Law), issued in DO 19, s. 2008, and reiterated in DepEd Memorandum No. 041, s. 2024.

Dear Mr. Tañada:

This has reference to your letter dated October 19, 2016 addressed to Secretary Leonor M. Briones seeking clarification on the no-collection policy as stated in Section 3 of Republic Act (RA) No. 5546, *An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from the Students and Teachers of Public and Private Schools, Colleges and Universities (Ganzon Law)*.

In your letter, you specifically wanted clarification on the following questions:

1. Will there be any violation of the law if we will go to the schools and explain about our presentation and invite the teachers and the students to watch our presentation on purely voluntary basis?
2. Will there be any violation of the law if the students will go voluntarily to the venue of our play and purchase the tickets for the show there?
3. Will there be any violation of the law if we will write a letter to the parents inviting their children to watch our show?

With reference to the above-cited provision, the law does not prohibit the sponsoring organization from inviting the teachers and students to watch the presentation. In fact, such act is allowed by the Department considering that this Department has already issued an Advisory for your presentation which authorized the conduct or implementation thereof.

As regards your second and third queries there will be no violation of the law if the sale of the tickets happened within your establishment or at the venue of the presentation, provided that you do not engage the schools, its officials, teachers or staff in the distribution or sale of tickets or in the collection of payments. The same law also does not prohibit the act of directly writing to the parents inviting their children to watch your show, subject to the same qualification stated above.

We hope this clarifies the matter.
