

PRIVILEGE SPEECH

Hon. Dizon P. Namuag, MBA
SP Member, 9th City Council

Presiding Chair, majority floor leader, my distinguished colleagues in this august body, and all the community members present today and watching via *Facebook* live, maayong buntag kanatong tahanan!

My concern for today focuses on the yearbooks produced by educational institutions operating here in the City of Panabo. These yearbooks are cherished mementos that commemorate our experiences and milestones during our school years. Let me clarify, this speech is not intended to oppose the distribution of yearbooks. I firmly believe that every graduate should have the right to decide whether or not to avail themselves of this service. However, I have received various complaints and concerns from parents and students that truly piqued my interest, to wit:

1. **Excessive Delay in Yearbook Distribution** – Some educational institutions take more than three years to distribute yearbooks, with some cases experiencing indefinite delays.
2. **High Cost of Yearbooks** – The price of yearbooks in some institutions exceeds Php 3,000.00, making it financially burdensome for students.
3. **Mandatory Yearbook Fees** – Certain institutions make yearbook purchases compulsory by automatically including the cost in students' statements of accounts near graduation, limiting their ability to opt out.

What happens to the payments made by students if the yearbooks are not delivered? Can these students request a refund? Unfortunately, the answer is often no. Once a graduate pays for a yearbook, they are left with no choice but to wait, sometimes indefinitely.

As stated in **Article XIV, Section 2 of the 1987 Philippine Constitution**, the state is mandated to **establish, maintain, and support** a complete, adequate, and integrated system of education relevant to the needs of the people and society. Moreover, **CHED Memorandum Order No. 04, Series of 2008, which amends CHED Memorandum Circular No. 04, Series of 2005, states that all private and public higher education institutions are urged to refrain from requiring students to pay contributions for the annual yearbook.**

In light of this concern and to thoroughly address the matter, I would like to refer it to the **Committee on Civil Society Organizations**, jointly with the **Committee on Education**, for proper evaluation and recommendations. Additionally, I propose calling upon all **directors, graduating advisers and officers, and student publication representatives from public and private high schools and higher education institutions within Panabo City's jurisdiction** to further discuss this issue through a committee hearing.
