SEARCH FOR
WOMEN OF THE YEAR AWARD
“Celebrating the Exceptional Contribution of Women in the City of Panabo”

Purpose:

The Women of the Year Award is to recognize individuals who are emerging leaders, mid-career leaders and lifetime achievement leaders who have made outstanding contributions to improve the quality of life for women and inspire women's leadership and success in Panabo City.

Scope and Criteria for Selection:

The Search for Women of the Year in Panabo City shall be conducted covering all Barangays, Academe, Government Organizations (GOs) and Non-Government Organizations (NGOs), Solo Parents, Indigenous Community, Women with Disabilities, individuals, business sectors and other institutions.

Qualifications for Nomination:

1. Must be a resident of Panabo City for at least three (3) continuous or aggregate years;
2. Must have significant role in the promotion of the general welfare and development of Panabo City; and
3. Must be a leader or potential leader – recognized as a symbol of leadership in her specific field of work.

These awards will be given to individuals whose actions and accomplishments meet one or more of the following criteria:

1. Leadership/Professional Excellence

Exemplifies leadership and accomplishment in Panabo City in one of the following categories: Education; Employment (Self/Wage); Health and Wellness; Sports; Culture and the Arts; Law and Justice; Safety and Policing; Science and Technology; Media; Environment; Agriculture; Public Service or Civic Engagement, and has had a demonstrable impact on the community she serves.

2. Advocacy

Noted as a woman of inspiration that is recognized as a role model for others to make a difference. She actively promotes the status of women through her work to advance women's rights, status, or condition in the category of nomination.

3. Innovation

Recognized for implementing new and innovative concepts or ideas thereby improving existing norms and standards in her field of endeavor to benefit the community with evidence of success.

Demonstrates special commitment to equity and diversity in city, as evidenced by service for women historically underrepresented due to culture, race, ethnicity, gender identity, occupation, income, religion and geography.

4. Integrity

Demonstrates willingness to serve and assist women in their personal and professional development, with honesty, compassion and adherent to moral principles.

Types of Awards

- 1. Lifetime Legacy:** Recognizes a woman who has demonstrated superior leadership and success of over forty (40) years in her field of endeavor. The Lifetime Legacy recipient has a track record of long-term achievements, community involvement and professional growth. She is a woman known for her positive influence and competent abilities.
- 2. Promising Woman (under 30):** Recognizes a woman under age 30 who has had significant accomplishments and/or achieved notable success in her chosen profession. The Promising Woman recipient will be a young woman who is considered an up-and-coming star in her profession. (Recipient must be under age 30 on or before the date of the awarding.)
- 3. Cultural Ambassador Award:** Recognizes a woman who has made a substantial contribution to the community by dedicating herself to improving the lives of others through her work in the visual, literary, performing, film and cinema, and/or broadcasting fields. She is a strong supporter of women and strives to make a positive difference in the lives of others through her profession.
- 4. Change Catalyst Award:** Recognizes a woman who has made significant contributions in her field or community that has led to inspiring change and/or innovation. She displays the application of development principles to create solutions for social, cultural, spiritual and environmental challenges through her work as a compassionate and loving humanitarian.
- 5. Volunteer Service Award:** Recognizes an outstanding woman volunteer for her exemplary performance and achievements in empowering communities and encouraging volunteerism as a way of life, helpful to nation-building. The Volunteer Service recipient has contributed time, service, and resources, whether full-time or part-time, to a just and essential social development cause, mission, or endeavor in

the belief that her activity is mutually meaningful and beneficial to the public interest.

6. **Health and Wellness Advocate Award:** Recognizes a woman who is an influential leader and advocate for the bigger picture related to good health and wellness practices and solutions is a mammoth task. The recipient of this award champions for good health and wellness through personal endeavors, achievements, recognition and/or scientific acclaim. Her work in this field and her advocacy has significance.
7. **Kabiyaan Award:** Recognizes a woman who raises the bar for indigenous people to be seen, heard and respected by using her voice. The recipient of Kabiyaan Award is a change agent and role model.
8. **Entrepreneur Award:** Recognizes an outstanding woman who is acknowledged in business and industry for her exemplary leadership. She is committed to excellence, creates and inspires a positive work environment, and influences and motivates positive change in her business, industry, trade, or workplace.
9. **Exemplary Solo Parent Award:** Recognizes a single-parent mother who has preserved in the face of adversity and demonstrated resiliency. With dignity and grace, she has transformed her life and the lives of her children. Her children see her as a role model. She is a single mom's mentor and advocate. She leads by example, demonstrating that she can accomplish it, so can you.
10. **Exceptional PWD Woman Award:** Recognizes a PWD woman who excel in spite of her disability. She's able to function her psychosocial and economic activities within her family and community. She influences and empowers other PWDs for a positive attitude towards the society.

Search Procedure

A. Nomination Process:

1. Who can nominate?

Any bonafide resident of Panabo City who are of legal age with extensive knowledge of the nominee's characteristics, leadership attributes, accomplishments and contributions.

2. Nomination Requirements:

- a. Fully accomplished Nomination form, duly signed by the nominator; which can be downloaded via Google Drive (link) or at the Gender and Development Office or at the City Administrator's Office through the Search Secretariat;
- b. Nominee's profile highlighting her background or curriculum vitae, accomplishments and/or milestone achievements and how she exemplifies above-mentioned criteria with a maximum 500 word count (Cebuano/Tagalog/English);

- c. Barangay Certification as proof of residency of the nominee and of good moral character; and
- d. Proof of milestone achievements (ex. photos of citations, certifications, trophies, plaques, etc.).

3. Submittal and Screening

- 1. The deadline for the submission of nominee will be on **February 21, 2025** through Google Form (link will be provided) or personal submission at the Gender and Development Office, Panabo City Parks and Plaza, Barangay New Pandan, Panabo City;
- 2. Each submittal shall be screened by the secretariat to ensure that all the requirements are complete (based on the checklist) and submitted on or before the set deadline. Incomplete and late nominations shall no longer be accepted.

4. Validation

- 1. The members of the screening committee shall validate all nominations to include document review, background investigation or interviews, as may be necessary.
- 2. The validation report shall be deliberated by the committee en banc.
- 3. A recommendation shall be endorsed to the Local Chief Executive for his concurrence and approval.

Awards and Prizes

- 1. The Ten Women of the Year shall be awarded with a plaque, token and cash worth Five Thousand Pesos (Php5,000.00) each.

The awardees will be presented to the public during a fitting Recognition and Awards Ceremony and Program on March 24, 2025 at the Panabo City Gymnasium during Gabi ng Parangal.

The Ceremony will also include or be followed by a Testimonial Lunch or Dinner in honor of the awardees, together with their immediate families or chosen guests.

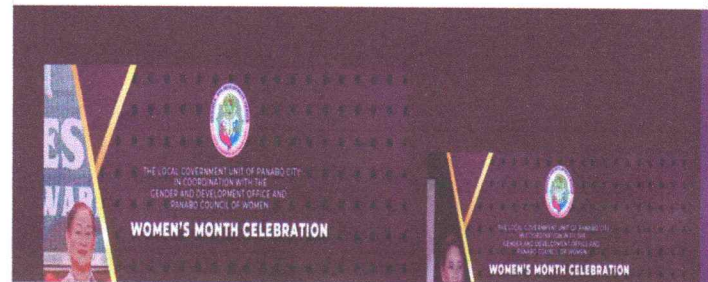

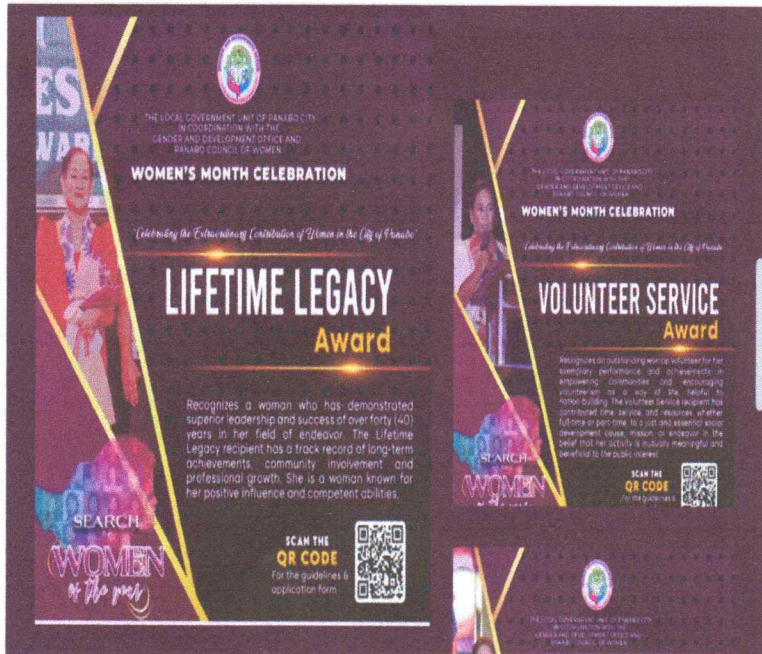

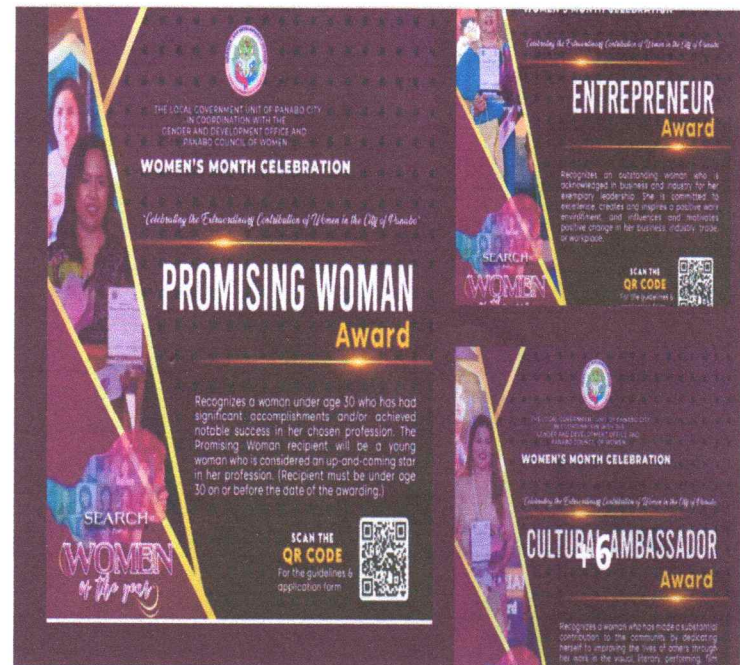

Exemplifies leadership and accomplishment in Panabo City in one of the following categories: Education; **Jobs and Economy** – Employment (Self/Wage); Health and Wellness; Sports; Culture and the Arts; Law and Justice; Safety and Policing; Science and Technology; Media; Environment; Agriculture; Public Service or Civic Engagement, and has had a demonstrable impact on the community she serves.

2. Advocacy

Noted as a woman of inspiration that is recognized as a role model for others to make a difference. She actively promotes the status of women through her work to advance women’s rights, status, or condition in the category of nomination.

3. Innovation

Recognized for implementing new and innovative concepts or ideas thereby improving existing norms and standards in her field of endeavor to benefit the community with evidence of success.

Demonstrates special commitment to equity and diversity in city, as evidenced by service for women historically underrepresented due to culture, race, ethnicity, gender identity, occupation, income, religion and geography.

4. Integrity

Demonstrates willingness to serve and assist women in their personal and professional development, with honesty, compassion and adherent to moral principles.

Types of Awards

1. **Lifetime Legacy:** Recognizes a woman who has demonstrated superior leadership and success of over forty (40) years in her field of endeavor. The Lifetime Legacy recipient has a track record of long-term achievements, community involvement and professional growth. She is a woman known for her positive influence and competent abilities.
2. **Promising Woman (under 30):** Recognizes a woman under age 30 who has had significant accomplishments and/or achieved notable success in her chosen profession. The Promising Woman recipient will be a young woman who is considered an up-and-coming star in her profession. (Recipient must be under age 30 on or before the date of the awarding.)
3. **Cultural Ambassador Award:** Recognizes a woman who has made a substantial contribution to the community by dedicating herself to improving the lives of others through her work in the visual, literary, performing, film and cinema, and/or broadcasting fields. She is a strong supporter of women and strives to make a positive difference in the lives of others through her profession.
4. **Change Catalyst Award:** Recognizes a woman who has made significant contributions in her field or community that has led to inspiring change and/or innovation. She displays the application of development principles to create solutions for social, cultural, spiritual and environmental challenges through her work as a compassionate and loving humanitarian.
5. **Volunteer Service Award:** Recognizes an outstanding woman volunteer for her exemplary performance and achievements in empowering communities and encouraging volunteerism as a way of life, helpful to nation-building. The Volunteer Service recipient has contributed time, service, and resources, whether full-time or part-time, to a just and essential social development cause, mission, or endeavor in the belief that her activity is mutually meaningful and beneficial to the public interest.

6. **Health and Wellness Advocate Award:** Recognizes a woman who is an influential leader and advocate for the bigger picture related to good health and wellness practices and solutions is a mammoth task. The recipient of this award champions for good health and wellness through personal endeavors, achievements, recognition and/or scientific acclaim. Her work in this field and her advocacy has significance.
7. **Kabiyaan Award:** Recognizes a woman who raises the bar for indigenous people to be seen, heard and respected by using her voice. The recipient of Kabiyaan Award is a change agent and role model.
8. **Entrepreneur Award:** Recognizes an outstanding woman who is acknowledged in business and industry for her exemplary leadership. She is committed to excellence, creates and inspires a positive work environment, and influences and motivates positive change in her business, industry, trade, or workplace.
9. **Exemplary Solo Parent Award:** Recognizes a single-parent mother who has preserved in the face of adversity and demonstrated resiliency. With dignity and grace, she has transformed her life and the lives of her children. Her children see her as a role model. She is a single mom's mentor and advocate. She leads by example, demonstrating that she can accomplish it, so can you.
10. **Exceptional PWD Woman Award:** Recognizes a PWD woman who excel in spite of her disability. She's able to function her psychosocial and economic activities within her family and community. She influences and empowers other PWDs for a positive attitude towards the society.

Search Procedure

A. Nomination Process:

1. Who can nominate?

Any bonafide resident of Panabo City who are of legal age with extensive knowledge of the nominee's characteristics, leadership attributes, accomplishments and contributions.

2. Nomination Requirements:

- a. Fully accomplished Nomination form, duly signed by the nominator; which can be downloaded via Google Drive (link) or at the Gender and Development Office or at the City Administrator's Office through the Search Secretariat;
- b. Nominee's profile highlighting her background or curriculum vitae, accomplishments and/or milestone achievements and how she exemplifies above-mentioned criteria with a maximum 500 word count (Cebuano/Tagalog/English);
- c. Barangay Certification as proof of residency and of good moral character; and

- d. Proof of milestone achievements (photos of citations, certifications, trophies, plaques, etc.).
3. Submittal and Screening
 1. The deadline for the submission of nominee will be on **February 28, 2025** through Google Form (link will be provided) or at the Gender and Development Office, Panabo City Parks and Plaza, Barangay New Pandan, Panabo City;
 2. Each submittal shall be screened by the secretariat to ensure that all the requirements are complete (based on the checklist) and submitted on or before the set deadline. Incomplete and late nominations shall no longer be accepted.
4. Validation
 1. The members of the screening committee shall validate all nominations to include document review, background investigation or interviews, as may be necessary.
 2. The validation report shall be deliberated by the committee en banc.
 3. A recommendation shall be endorsed to the Local Chief Executive for his concurrence and approval.

Awards and Prizes

1. The Ten Women of the Year shall be awarded with a plaque, token and cash worth Five Thousand Pesos (Php5,000.00) each.

The awardees will be presented to the public during a fitting Recognition and Awards Ceremony and Program on **March 20, 2025 – March 24, 2025** at the Panabo City ,.... (Complete Name) Gym during Gabi ng Parangal.

The Ceremony will also include or be followed by a Testimonial Lunch or Dinner in honor of the awardees, together with their immediate families or chosen guests.
