This Service Credits and COC shall be on top of the maximum 40 hours in a month.

Expenses relative to the In-house training and participation of the delegates to DAVRAA 2025 including transportation, foods and snacks shall be charged against the Local School Board (LSB) under the Special Education Fund (SEF), and Division MOOE/other funds subject to the usual auditing and accounting rules and regulations.

- To ensure the smooth conduct of all games, all **Officiating Officials** (Tournament Managers/Asst. Tournament Managers /Technical Officials) are required to be present during the scheduled **Refresher Course**. While **coaches** are required to attend the **Solidarity Meeting**. As per agreed during the Orientation/Refresher/Workshop of all Division Sports Officers (DOs) and all Regional Tournament Managers (TMs), a **coach who failed to attend the Solidarity Meeting will not be allowed to participate in the 2025 DAVRAA Meet**, unless justified due to extreme and/or life-threatening circumstances and shall submit/secure written justification duly recommend by the Schools Division Superintendent (SDS) and approval from the undersigned.
- All Division Working Committees/delegation officials are required to submit to the secretariat committee a recent **medical certificate (as of CY 2025)** to ensure that those who will serve during the meet are fit and health and bring with them sleeping mattresses and food paraphernalia.
- Additional and relevant information relative to the conduct of the 2025 DAVRAA Meet will be issued through a separate Memorandum.
- School heads shall ensure that a substitute teacher will take over the classes in the absence of their respective teaching personnel who will participate to the 2025 DAVRAA Meet to prevent disruption of classes. Schools which will be used as the billeting quarters during the In-house training shall implement the blended modality instruction.
- Delegation officials, coaches, chaperons, and DepEd Personnel who will participate/serve in this event are requested to be granted with Service Credit or Compensatory Overtime Credit (COC), whichever applies, for services rendered on weekends/holidays as per DepEd Order No. 53, s. 2003 and CSC-DBM Joint Circular No. 02, s. 2004, respectively.
- Expenses relative to the In-house training and participation of the delegates to DAVRAA 2024, including transportation, foods, and snacks shall be charged against the Local School Board (LSB) under Special Education Fund (SEF), and school MOOE/other funds subject to the usual auditing and accounting rules and regulations.
