Relative to the Regional Memorandum No. CLMD-2025-219, this Office encourages the private schools to adopt the Summer Academic Remedial Program (SARP) to cater to learners who are eligible for the program.

A letter of Request to offer SARP shall be submitted to the Office of the Schools Division Superintendent. Upon approval of the request, schools shall prepare the following requirements for submission to the SDO through the SARP focal, **Ylcy B. Manguilimotan**, EPS:

- a. List of Students per Grade Level;
- b. List of Least Mastered Competencies per Learner;
- c. List of Learning Areas to be Offered per Grade Level;
- d. List of Teachers and Subjects they will teach;
- e. Class Program; and
- f. Parent's Consent.

Private schools shall abide by the guidelines stipulated in DM 35, s. 2025 re: Supplemental Guidelines for the Implementation of the Summer Academic Remedial Program.

Immediate dissemination of this Memorandum is desired.

**IMPLEMENTATION OF SUMMER ACADEMIC REMEDIAL PROGRAM (SARP)
OF THE PRIVATE SCHOOLS**

To: Schools Division Superintendents

1. Relative to Regional Memorandum CLMD-2025-219 this Office advises the Schools Division Offices that private schools are encouraged to adopt the Summer Academic Remedial Program (SARP). This implies that private schools have to cater the learners eligible for the program.
2. Letter of Request to offer SARP shall be submitted to the Schools Division Superintendent. After the request has been approved, schools shall prepare the following requirements for submission to the SDO:
 - a. List of Students per Grade Level;
 - b. List of least mastered competencies per learner;
 - c. List of learning areas/to be offered per grade level;
 - d. List of teachers and subjects they will teach;
 - e. Class program; and
 - f. Parent's consent.
3. Private schools shall implement the guidelines stipulated in DM 35 s. 2025 entitled: Supplemental Guidelines for the Implementation of the Summer Academic Remedial Program.
4. Learning assessment for SARP shall be in accordance to DO 8 s. 2015, including the computation of grades.
5. Immediate dissemination of this Memorandum is desired.
