Virtual Orientation on the Administration of the Dynamic Learning Program (DLP) Assessment for High School for School Year 2025 – 2026

1. Pursuant to the DepEd Unnumbered Memorandum dated May 20, 2025, titled *"Pilot Schools of the Dynamic Learning Program"*, the Bureau of Education Assessment – Education Research Division (BEA-ERD) has been requested to lead the design and implementation of *baseline, midline, and endline* assessments for DLP to evaluate its pilot implementation.
2. In line with this, the BEA-ERD invites all **Regional Testing Coordinators (RTCs), Division Testing Coordinators (DTCs), Test Administrators (TAs), Deputy Assessment Monitors (DAMs), and School Heads (SHs) from the DLP pilot regions, schools division offices, and schools** to attend the *Virtual Orientation on the Administration of the DLP Assessment for High School for School Year 2025–2026* on **June 11, 2025 (Wednesday)**.
3. Each RTC must nominate **Deputy Assessment Monitors (DAMs)** equivalent to 10% of the total number of sampled DLP schools per region. DAMs are public schools district supervisors assigned to areas near the DLP pilot schools.
4. Each DTC must nominate two (2) Test Administrators (TAs) per DLP school. Teachers with prior experience in administering standardized tests are preferred.
5. The virtual orientation will cover the guidelines on the production, delivery, and retrieval of test materials, as well as test administration procedures, including the roles and responsibilities of testing personnel and instructions on the use of Program Support Funds (PSF).
