

AN ORDER CREATING THE DAVAO DEL NORTE PROVINCIAL YOUTH ADVISORY COUNCIL

WHEREAS, Article 2, Section 13 of the 1987 Philippine Constitution mandates the State the promotion and protection of physical, moral, spiritual, intellectual, and social well-being of the youth since they are vital in nation-building;

WHEREAS, Section 2 of Republic Act 10742 otherwise known as the Sangguniang Kabataan Reform Act provides that the State shall establish adequate, effective, responsive, and enabling mechanisms and support systems that will ensure the meaningful participation of the youth in local governance and nation-building;

WHEREAS, Section 14 of Republic Act 8044, otherwise known as "The Youth in Nation-Building Act" strengthens the existence of youth advisory councils in national and regional levels;

WHEREAS, in cognizance of the importance of youth in society, the Provincial Government of Davao del Norte through its K.U.Y.A. G.O.B. N.G. M.A.S.A Developmental Agenda intends to formulate programs, projects, and policies that would be beneficial to them;

WHEREAS, in view of this goal, there is a need to create a Provincial Youth Advisory Council in the Province of Davao del Norte that will take charge of its various youth-related endeavors;

WHEREAS, a similar advisory council at the provincial level would provide a venue for the consolidation of issues concerning the youth and for quick coordination to address these;

NOW THEREFORE, I, EDWIN I. JUBAHIB, Governor of the Province of Davao del Norte, by the power vested in me by law, do hereby order the creation of the Provincial Youth Advisory Council of the Province of Davao del Norte as detailed in the following, to wit:

Section 1. Composition. The Davao del Norte Provincial Youth Advisory Council shall be composed of the following:

Section 2. Roles and Responsibilities. The Davao del Norte Provincial Youth Advisory Council shall perform the following roles and responsibilities, to wit:

- 2.1 Provide reports and updates on all youth-related affairs and activities, including but not limited to, plans, programs, and projects intended for the youth sector of the Province;
- 2.2 Coordinate with and recommend to the Provincial Youth Development Council strategies of implementation for short, medium, and long-term youth development programs and activities of the Province; and
- 2.3 Recommend to the Provincial Governor, through the Local Youth Development Council (LYDC), the programs, projects, and activities (PPAs) for the youth based on the consolidated felt needs as discussed in the council.

Section 3. Meetings. The council shall meet once every three (3) months or as often as deemed necessary, upon the call of its Chairperson, on important matters relating to youth affairs, welfare, and development.

The Council may form task forces that shall convene between meetings of the Council. The Provincial Sports and Youth Development Office shall provide the technical support and the Secretariat required to function as this Order requires.

Section 4. Repealing Clause. All other executive orders, previous issuances, orders, and memorandums inconsistent with the provisions of this Order shall be deemed revoked or repealed, modified, or amended accordingly.

Section 5. Effectivity. This executive order shall take effect immediately upon signing.
