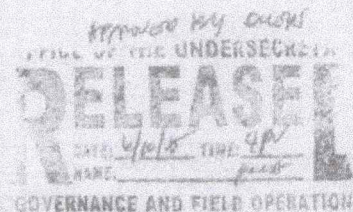

(SBFP) EVALUATION AND FEEDBACK SURVEY (EFS) FOR
SY 2024-2025**

DATE : June 2, 2025

The Operation Strand, through the Bureau of Learner Support Services-School Health Division (BLSS-SHD), shall conduct the School-Based Feeding Program Evaluation and Feedback Survey (SBFP-EFS) for SY 2024-2025. It is worth mentioning that the SBFP-EFS was conducted in SYs 2020-2021 and 2023-2024. The results of these surveys were extensively used to defend the budget proposals in succeeding years and in the review of the program.

The intended respondents of these surveys are the parents or guardians of the learner-beneficiaries and the school heads who implemented the pilot universal feeding in kindergarten. This survey seeks to gather feedback from the parents or guardians on the program's impact among beneficiaries, and from the school heads, feedback regarding the SBFP implementation and management for SY 2024-2025.

The Regional and Schools Division SBFP Focal Persons are requested to disseminate the link to the respective schools who implemented the SBFP for SY 2024-2025 and fill out the online form for the respective respondents.



Methodology of the Survey

1. Questionnaire for Parents/Guardians:

- a. The SBFP EFS Survey Questionnaire for Parents/Guardians are conducted via Microsoft forms and can be accessed through this link:

- b. The SDO Focal Person shall choose the participating schools to answer the EFS for the parents or guardians. The participants of the survey must cover at least 50% of the SBFP pilot schools for universal feeding in kindergarten.
- c. The SDO Focal Person shall send the link to the School Heads, who shall send it to Class Advisers, who shall be responsible for sharing it to selected learner beneficiaries and parents/guardians.
- d. The link will be sent via email or Facebook messenger group chat.

2. Questionnaire for School Head:

- a. The SBFP EFS Survey Questionnaire for School Head is conducted via Microsoft forms and can be accessed through this link:

- b. The SDO Focal Person shall choose the participating schools to answer the EFS for the school head. The participants of the survey must cover at least 50% of the SBFP Recipient schools in every SDO

The survey questionnaires shall be open for administration from **June 4-20, 2025**.
