For the Performance Validation Stage, kindly accomplish and submit a copy of the following requirements via email at vbordeos@cesboard.gov.ph:

- (1) Personal Data Form and Profile (downloadable at the CESB website)
- (2) Organizational chart showing your place in the organization;
- (3) List and contact numbers of your Personnel Officer/HRMO, immediate superior/s and subordinates;
- (4) Recent appointment paper and service record;
- (5) Clearances from the Civil Service Commission, the Office of the Ombudsman, and the Sandiganbayan;
- (6) Detailed information about pending case/s, if any;
- (7) Recent performance rating for CY 2023/2024 certified by agency personnel;
- (8) Sworn Statement of Assets, Liabilities and Net Worth, Disclosure of Business Interests and Financial Connections and Identifications of Relatives in the Government Service for the past three (3) consecutive years;
- (9) Recent Employer's Certificate of Compensation Payment/Tax Withheld (BIR Form No. 2316). Should you have other business interest other than your employment in the government, kindly submit also the recent Annual Income Tax Return for Self-employed (BIR Form No. 1701).

**Please note that all requirements except for item (5) Information on Pending Cases should be certified by your Personnel Officer/HRMO.*

A minimal fee of EIGHT HUNDRED PESOS (Php 800.00) shall also be paid to cover the cost of publication fee. Payments may be paid at the CESB office or may be deposited in CESB's Land Bank of the Philippines Account Number 0622-1022-34 payable to the CAREER EXECUTIVE SERVICE BOARD. For Interbranch payments, kindly e-mail a copy of the deposit slip indicating participant's name, agency and branch location where payment was deposited at vbordeos@cesboard.gov.ph.
