Greetings from the Department of Health.



Concept Note
**2025 Online Oplan Kalusugan sa DepEd - Healthy Learning Institutions
Onboarding**

I. Rationale

Section 30 of Republic Act No. 11223, or the Universal Health Care (UHC) Act, designates schools under the supervision of the Department of Education (DepEd) as healthy settings. To operationalize this mandate, the Department of Health (DOH), through the Health Promotion Bureau (HPB) and its Centers for Health Development (CHDs), implements the Oplan Kalusugan sa DepEd - Healthy Learning Institutions (OKD-HLI) program. This program aims to assist schools in institutionalizing health promotion by providing technical and financial assistance, with a special focus on Last Mile Schools (LMS) for consideration of equity.

Prior to the issuance of the OKD-HLI Manual of Procedure, an interim guidelines is to be issued to strengthen the selection and prioritization process for Province- and City-wide Health Systems (P/CWHS), clarify funding utilization, and detail the monitoring, evaluation, and recognition process for Basic Education Institutions (BEIs) aiming to become HLI-recognized for 2025. To ensure unified and effective implementation, an onboarding workshop is proposed.

II. Objectives

The onboarding workshop aims to:

1. Present the approved interim guidelines and the updated recognition process for 2025.
2. Clarify roles, responsibilities, and timelines of CHDs, P/CWHS, DepEd Regional Offices, and Schools Division Offices.
3. Address previously raised concerns about workshops, tools, and materials.
4. Introduce updated materials for capacity-building activities and program implementation.
5. Ensure alignment and readiness of regional teams to implement and monitor the HLI program for 2025.

III. Participants

The two-day workshop to be held on 14- 15 July 2025 via Zoom Online meetings and will cover learning and planning for the implementation of the 2025 OKD-HLI program, and will be participated by the following:

1. DepEd School Health Division (SHD)
2. DOH Central Office - Health Promotion Bureau (DOH-HPB)
3. 34 representatives from the DOH CHDs (2 per CHD);
4. 34 representatives from the DepEd ROs (2 per region); and,
5. 1 representative per SDO (for the second day only)
