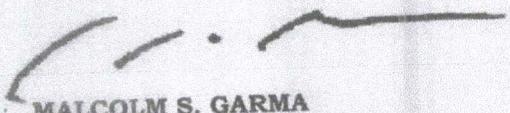

The Department of Education (DepEd) and Frontlearners Inc. have entered a Memorandum of Agreement (MOA) to explore the use of Frontlearners' interactive digital learning resources featuring MATATAG curriculum-aligned content in Math, English, and Science, as well as in the six (6) new Senior High School subjects. These resources are supported by AI-generated feedback on students' responses to quiz questions, quarterly pre- and post-assessments, and real-time progress tracking to support targeted interventions. Using the same learning materials and assessments across platforms, the program is designed for online, offline, and printed formats to ensure inclusive access and promote consistent, data-informed teaching in diverse learning environments.

The objective of the program is to evaluate the effectiveness of technology-enabled instruction in improving learning outcomes, enhancing instructional quality, and reducing learning gaps. It also aims to assess the practicality of integrating digital content, frequent formative and timely summative assessments, real-time progress monitoring, and targeted interventions into everyday teaching practices. The program

seeks to generate data and insights that will inform potential large-scale implementation in support of DepEd's commitment to quality and inclusive basic education.

DepEd and Frontlearners agreed to pilot test the digital learning resource in 510 schools across all regions (30 schools per region) and all provinces (each province should include at least one urban and one rural school). Below is the process and considerations in nominating schools:

A. Selecting pilot schools for Front Learners.

Schools must have the following:

1. Internet Connectivity with Wi-Fi signal reaching the classrooms or an Ethernet wire connection in the classroom (mainly for teachers' use during class);
2. Smart TV/regular flat TV for Math, Science, and English (Reading and Grammar) for selected grade level(s);
3. Laptops for teachers handling Math, Science, and English classes are to be connected to the school's internet;
4. Computer room with at least 25 laptops/tablets or e-carts with 25 devices for use by students during the mandatory quarterly pre- and post-tests; and
5. Electrical Power supply, preferably with backup that can also revert to alternative delivery mode to simulate real classroom situation.

B. Considerations in selecting schools:

1. Must include at least 1 rural school and 1 urban school per province;
2. Must be a combination of Elementary, Junior High School and Senior High School (all public schools); and,
3. Must not include Khan Academy schools.

C. Instruction to Regional Directors

1. All RDs must nominate 30 schools based on A and B.
