

FOR : ALL CITY/MUNICIPAL MAYORS, PUNONG BARANGAYS, DILG REGIONAL DIRECTORS, DILG FIELD OFFICERS, AND OTHERS CONCERNED

SUBJECT : DEPLOYMENT OF BARANGAY TANODS IN DEPARTMENT OF EDUCATION SCHOOLS

DATE : JUL 24 2025

In support of President Ferdinand R. Marcos Jr.'s directive to ensure student safety, the Department of Education (DepEd) identified action points for the Department of the Interior and Local Government (DILG) for School Year 2025–2026. One of these is the deployment of Barangay Tanods to help ensure the safety and security of students in public schools.

As provided under Section 391 (a) (16) of Republic Act No. 7160 or the Local Government Code of 1991, barangays are authorized to organize *tanods* or community service units to support peace and order efforts. Consistent with DILG Memorandum Circular No. 2024-086¹, barangay *tanods* are expected to assist in crime prevention, conduct patrols, and coordinate with local authorities in addressing threats to public safety, including crimes affecting children and schools.

In this regard, all barangays are hereby requested to coordinate with the DepEd schools under their jurisdiction for the deployment of barangay *tanods*, who shall perform the following tasks in line with their mandated duties and responsibilities to ensure the safety and security of learners, parents, school employees, and officials:

- a) Manage traffic and assist learners and school employees during the arrival and dismissal of morning and afternoon classes;
- b) Conduct regular patrols, especially at schools' main entry points and adjacent public spaces frequented by students, to augment the increased and sustained police visibility in the vicinity;



- c) Closely monitor any untoward incidents that may endanger students, teachers, staff, or parents and report them immediately to authorities; and
- d) Perform other functions as instructed by the Punong Barangay or law enforcement authorities to strengthen security and safety measures in schools.

In connection with the above, all city and municipal mayors are hereby requested to provide necessary assistance to the barangays in line with the deployment of barangay tanods.

All DILG Regional Directors and Field Officers are directed to cause the immediate and widest dissemination of this Memorandum Circular.
