Subject : **CALL FOR SUBMISSION OF LOCALLY-DEVELOPED TEACHING AND LEARNING RESOURCES (LDTLR) FOR QUALITY ASSURANCE**

Date : September 12, 2025

The Curriculum Implementation Division (CID) through the Learning Resource Management Section calls for the submission of locally-developed teaching and learning resources which are originally written, illustrated, or designed by teachers for classroom use. These resources shall be subjected to quality assurance and uploaded to the Learning Resource (LR) Portal once specialty clearance is issued.

Resources that may be submitted include **stories, poems, learning activity sheets, lesson exemplars, strategic intervention materials, digitized lessons, and/or recorded video lessons**. Please ensure that the content and illustrations of the resources are **contextualized** and **copyright-free**—not copied anywhere, even from DepEd textbooks, modules, and any other references.

Each resource must be placed in a separate envelope containing the material and completed LDTLR Metadata form (see attachment). There is no limit to the number of submissions per teacher.

All school LR coordinators, with the LR Committee, are required to conduct initial evaluation of the materials to ensure adherence to the guidelines, particularly on copyright issues. Only endorsed materials will be accepted at the Division level.

All envelopes for submission must be forwarded to the LRMS Office (Library Hub) inside PCESSC Compound from October 1 to 15, 2025.
