



SUBJECT : STRENGTHENING COORDINATION AND MONITORING OF
SCHOOL INFRASTRUCTURE PROGRAMS

DATE : July 31, 2025

To ensure the timely and effective implementation of school infrastructure programs, this Office underscores the importance of engaging personnel at all governance levels in identifying critical infrastructure issues, addressing implementation bottlenecks, and improving project monitoring and reporting mechanisms. In line with this, all Regional Offices (ROs), Schools Division Offices (SDOs), and District personnel are hereby directed to:

1. Identify and Report Infrastructure Issues

- Conduct consultations with school heads and stakeholders to gather site-level data on pressing infrastructure concerns (e.g., classroom shortages, repairs needed, buildability constraints, obstructions).
- Submit regular updates and reports to the ESSD/SGOOD and the Education Facilities Division (EFD) for consolidation and action.

2. Flag and Address Implementation Bottlenecks

- Monitor project milestones and timelines in coordination with implementing agencies (e.g., DPWH, NEA) and immediately flag delays due to procurement, documentation, site readiness, or other local issues.
- Recommend actions or interventions to resolve identified issues at the field level.

3. Participate in Program Monitoring Activities

- Joint site inspections, validation activities, and joint monitoring visits as may be scheduled by the RO or Central Office.
- Assist in verifying physical accomplishments, occupancy status, and program compliance of completed infrastructure projects.

4. Promote Accountability and Transparency

- Ensure timely submission of reports, documentation, and feedback related to infrastructure programs.
- Encourage active community participation and feedback in infrastructure-related concerns through school governance councils. The active involvement of RO, SDO, and District personnel is crucial in ensuring that infrastructure programs respond to actual needs on the ground and are implemented efficiently and transparently.
