1. The Department of Education Regional Office XI through the Education Support Services Division in partnership with the Provincial Health Office of Davao del Norte will be conducting Regional Workshop on the Pilot Implementation of Youth Suicide Death Review for the Established Learner Support Centers in the Province of Davao del Norte on **September 9-10, 2025** at the **Grand Palm Villas and Hotel, Purok Saging, Visayan Village, Tagum City**.
2. The activity aimed to review root causes of suicide, effectiveness of prevention and intervention measures, set clear roles and responsibilities of every stakeholder and create postvention strategies with the goal in reducing the number of youth suicide cases in the Region, which recorded 88 deaths by suicide as per BEIS data on SY 2024-2025, with 21 cases coming from the SDOs under the Province of Davao del Norte.
2. Anent to this, it is requested that the Regional/SDO Focal Persons on School Mental Health Program and Child and Adolescent Reproductive Health in Davao del Norte, together with the identified Registered Guidance Counselors working in the pilot implementation (Annex) attend the activity. Further, the activity will be participated as well by the different identified stakeholders working on the implementation of the programs. The activity is hosted by SDO – Davao del Norte.
3. Travelling and other incidental expenses shall be charged against local funds while venue, meals and accommodation shall be covered by the downloaded Program Support Funds on Child and Adolescent Reproductive Health, subject to the usual accounting and auditing rules and regulations.
