
- d. Informed consent and assent must be acquired from all participants and their parents/guardians (please see attached forms);

The Commission on Population and Development (CPD) Region XI has engaged the expertise of the Ateneo de Davao University Migration Center (AMC) to conduct a research study this year entitled ***"Beyond the Space: Understanding Adolescent Experiences and Perceptions in Teen Center Utilization in Region XI."***

Through this study, we aim to generate evidence-based insights that will inform adolescent-driven policy recommendations, strengthen adolescent-focused program implementation, and enhance the overall impact of Teen Centers. The results will serve as a foundation for improving service delivery, fostering stronger adolescent-stakeholder collaboration, and ensuring that Teen Centers remain responsive, relevant, and truly adolescent-centered.

In this regard, the AMC Research Team will conduct the visit and data gathering activity to the following Schools Division Offices. Thus, we respectfully seek the assistance of DepEd Region XI in facilitating the dissemination of this information to the following Schools Division Offices:

- Davao de Oro (*between September 1-4, 2025*)
- Davao Oriental (*between September 1-4, 2025*)
- Davao del Norte (*between September 5 and 8, 2025*)
- Tagum City (*between September 5 and 8, 2025*)
- Panabo City (*between September 5 and 8, 2025*)
- Island Garden City of Samal (*between September 5 and 8, 2025*)
- Davao City (*between September 9-10, 2025*)
- Davao del Sur (*within September - to be communicated immediately once finalized*)

We further request the support of the Adolescent Reproductive Health (ARH) Coordinators in the identified Teen Centers to assist in the following:

1. Select or identify **one (1) Adolescent Client per Teen Center** who meets the following criteria:
  - Must be 10 to 19 years old;
  - Must be residing in Davao Region for at least 6 months prior to the survey;
  - Has accessed the teen centers for the past six (6) months;
  - May include participants from all gender identities to reflect diverse experiences and needs (LGBTQ, PWD, IP etc.);
  - Representation from various socio-economic classes to assess equitable access to and utilization of teen center services;
  - Includes in-school youth (junior high or senior high) and out-of-school youth to capture varying levels of awareness and utilization;
  - Inclusive of adolescents with different health needs, including those with existing health conditions who may have sought services from teen centers;
  - Willing to participate voluntarily and provide informed consent (and parental consent for minors).
2. Secure the necessary Written Consent of the participant or of the parent/guardian (for minors).
3. Be available during the scheduled interviews to provide coordination support; and
4. Ensure privacy during the interview process by allowing only the interviewer and participant to be present.






