

SUBJECT : SPECIAL MEETING AND OCULAR VISIT OF THE JAMBORETTE CAMPSITE AND OTHERS DETAILS


1. The Island Garden City of Samal Scouting Committee will play host the 36th Council Jamborette and 2nd Council Rover Moot of the Davao del Norte Council, Boy Scouts of the Philippines on October 27-30, 2025 at Freedom Park, Peñaplata, IGACOS. Some 2,000 or more Scouts/Scout Leaders coming from the Eight (8) Municipalities and Two (2) component Cities of Davao del Norte are expected to participate in this Council-wide Scouting event.
2. And as such, during the Joint Jambo Staff and Unit Leaders Conference/Meeting it was unanimously agreed that all Municipal/City Scout Coordinators, District Field Scout Commissioners, Unit Leaders and the Jamborette Staff will conduct an OCULAR VISIT/INSPECTION of the Jamborette Site on October 7, 2025.
3. The details of the "Ocular Jamborette Site Visitation" are as follows:

ASSEMBLY AREA	: <u>Freedom Park, Peñaplata, Island Garden City of Samal</u>
ASSEMBLY TIME	: <u>9:00 o'clock in the morning and at 10:00 A.M.: Special Meeting and Area Visitation</u>
4. Considering that the Council is presently facing limited financial resources, it is requested that the representative from every Municipal/City Scouting Committee shall provide their own transportation expenses from point of origin to the venue back and forth.
5. It is desired that all District/City Municipalities will be properly represented in the aforesaid "Ocular Visit of the Jamborette Campsite" in order to determine the area size needed by their respective contingent, and meet the basic requirements for participation.
6. After specification and determination of the area for the respective Schools/District/Municipal/City Contingent, the campsite area is declared open for Advance Party starting October 25, 2025 for the construction of their respective contingent camp and it is suggested that the 36th Council Jamborette Contingent will do break camp on 31 October 2025.
