DISSEMINATION OF ADVISORY, RE: POSTPONEMENT OF THE ADMINISTRATION
 OF DYNAMIC LEARNING PROGRAM (DLP) PRETEST ASSESSMENT

To: Schools Division Superintendents

1. This Office hereby disseminates Advisory No. 026, s. 2025 issued by the Bureau of Education Assessment (BEA) regarding the postponement of the administration of the Dynamic Learning Program (DLP) Pretest Assessment, originally scheduled on September 15-19, 2025, until further notice.
2. The postponement is due to the following considerations:
 - a. The pending approval of policy guidelines on DLP implementation, which are necessary to formally commence preparatory activities such as orientation and the administration of parental consent forms;
 - b. requests from Schools Division Offices (SDOs) for an extended procurement timeline to reproduce test materials; and
 - c. the need for additional preparation time to reproduce and deliver DLP Assessment materials to schools.
3. Immediate dissemination of this Memorandum is desired.
