**PARTICIPATION TO THE REGIONAL LEARNER RIGHTS AND PROTECTION (LRP)
SPECIALIZATION COURSE TRAINING-WORKSHOP**

To: Schools Division Superintendents

1. The Regional Office through the Education Support Services Division (ESSD) ensures a safe, positive, and rights-based learning environment for all the learners across the Region through the implementation of the Learner Rights and Protection Program.
2. Anent to this, ESSD will hold the Regional Learner Rights and Protection (LRP) Specialization Course Training-Workshop on November 11-14, 2025 at the Sunny Point Hotel, Ma-a, Davao City. The activity will be attended by Central Office Operations Strand Personnel, Regional/Division Focal Persons on Learners Rights and Protection, LRP Alternate Focal, selected Guidance Counselors/ Advocates, selected Public Schools District Supervisors, selected elementary and secondary school heads, and selected School Learner Formation Officer/ School LRP Designate.
3. Specifically, the activity aims to:
 - a. Strengthen preventive and responsive strategies to address the increasing cases of learner rights violations and child protection concerns within schools and divisions;
 - b. Develop a pool of trained LRP Specialists who will lead targeted interventions and provide responsive support services in their respective schools, districts, and divisions; and
 - c. Prepare re-entry plans and localized strategies to support the effective rollout of the LRP Frameworks Upskilling Program at the school and division levels.
4. Travelling and other incidental expenses shall be charged to local funds, subject to the usual accounting and auditing rules and regulations while venue, meals and accommodation will be covered by downloaded Learner Rights and Protection Program Support Funds.
5. Immediate and wide dissemination of this memorandum is desired.
