1. The Schools Division of Panabo City together with the Davao Regional Medical Center Blood Collecting Unit will conduct its 12<sup>th</sup> bloodletting activity entitle **"Hemogift: 12<sup>th</sup> bloodletting activity of SDO Panabo City"** on **November 8, 2025**, at the **New Visayas Gym, Brgy. New Visayas, Panabo City**. This activity aims to help replenish blood supply of blood blanks in the province.
2. With this all schools shall send at least two eligible donors to participate in the said activity to ensure number of donations. Here are the guidelines before donating blood.
  - a. Donors should be 50 kg and above.
  - b. Tattoos, post-operation patient, Anti-Rabies vaccine (at least 1 year after the procedure)
  - c. No food 2 hours prior to donating blood.
  - d. Good rest (at least 8 hrs of sleep) and hydrate prior to the day of donation.
  - e. Donors shall be in good physical condition (no cough, colds or fever) during the donation.
  - f. 16 years old and above are eligible to donate blood. (learners shall secure parents' consent)
3. Further, all schools shall submit the names of their eligible donors through the Google sheet master list ( <https://forms.gle/v1m7b2w0> ) on or before November 3, 2025.
4. Furthermore, this office grants Service Credits to teachers who successfully donated blood and Compensatory Overtime Credits (COC) to non-teaching participants for the services rendered on Saturdays, Sundays, or Holidays, as per DepEd No. 53. S. 2003.
