Subject: **VISION PROGRAM MONITORING AND REPORTING SY 2025-2026**

Date: October 23, 2025

In support of the ARAL Program and the implementation of the Health Assessment, this Office emphasizes the importance of monitoring and reporting learners' behaviors and complaints related to vision or eye health concerns.

The Vision Program aims to identify learners with potential visual difficulties that may hinder their participation and performance in classroom learning. As such, teachers and school health personnel are enjoined to observe and document learners who exhibit the following signs and complaints:

- Eye pain or discomfort
- Crossed or misaligned eyes (duling or banlag)
- Difficulty in reading or copying from the board
- Frequent squinting or rubbing of eyes
- Unusual head tilting or eye movement while reading
- Complaints of blurred or double vision

All observed cases and complaints shall be reported to the School Health and Nutrition Section (SHNS) using the prescribed Vision Program Monitoring and Reporting Form (Annex A). These reports will serve as the basis for further health assessment and referral to appropriate health professionals. The consolidated school report shall be submitted to the SHNS on or before **December 15, 2025**.

The SHNS shall validate and consolidate all submitted reports for Division-wide analysis and appropriate intervention planning in support of the ARAL Program's goal of addressing health barriers to learning.
