Anent thereto, the attached list of participants is hereby advised to prepare Authority to Travel duly signed by the immediate supervisor, recommended by the undersigned, and approved by the Local Chief Executive, Hon. Jose E. Relampagos. **Departure is on November 20, 2025, and return on November 24, 2025.**

Students involved must secure parental consent, and they will be given special quizzes, exams, and/or requirements by their respective subject teachers so as not to hamper their rehearsals and representation on the national stage.

Identified teachers are directed to arrange their respective schedules to avoid disruption of classes and institute measures to increase engaged time-on-task pursuant to the existing DepEd orders and mandates.

The safety and security of learners shall be always ensured, particularly during travel to and from practices, rehearsals, and competition proper.

For concerns, kindly coordinate to the NAMCYA organization, and inform this Office through Ramil Jacky P. Firman, MAPEH Education Program Supervisor, for updates.

This office grants service credits for teaching personnel and compensatory overtime credits (COC) for non-teaching personnel on services rendered during Saturdays, Sundays, and holidays.
