The Government Assistance and Subsidies Service (GASS) through the Operations and Data Management Division (ODMD) has developed an online platform known as the **JDVP Online Billing System (JOBS)**. The system is designed to facilitate ease of access to relevant data and resources for all Joint Delivery Voucher Program (JDVP) stakeholders, including DepEd administrators (GASS-ODMD), Regional Offices (ROs), Schools Division Offices (SDOs), public participating schools, and TVI partners.

To support a more harmonized and efficient implementation anchored on a trained pool of program implementers, standardized and validated processes, and viable mechanisms for monitoring and reporting JDVP learner-beneficiary progress, the GASS-ODMD will conduct the **Pilot Implementation and Roll-Out Orientation on the JOBS** for Luzon A, Luzon B, Visayas, and Mindanao Cluster within **Region VI** on **November 5-7, 2025**. Additionally, a separate advisory shall be issued to provide further details on the final venue and administrative arrangements.



The activity specifically aims to:

- Orient and train JDVP regional and division focal persons, ICT representatives, and public school JDVP coordinators on the functionalities and use of the JOBS.
- Standardize and digitalize system processes to ensure compliance with data privacy, reporting, and accountability requirements.
- Pilot-test and validate the JOBS to generate feedback and recommendations for refinement prior to nationwide implementation.

The aforementioned activity will cover all essential topics related to the pilot of JOBS as outlined in **Annex A (Program of Activities)**. The list of selected participants from Luzon A, Luzon B, Visayas, and Mindanao clusters shall attend the aforementioned activity as provided in **Annex B (List of Participants)**.

All transportation and other expenses of participants from the RO, SDO, and public school shall be charged against their local funds, subject to the usual COA guidelines.

For GASS-ODMD participants, traveling and other expenses shall be charged against ODMD local funds, subject to the usual COA guidelines.

Prior to the conduct of the pilot implementation and roll-out orientation of the JOBS, all participants must pre-register through the link on or before October 29, 2025: <https://tinyurl.com/JOBSPilotPRF>.

To ensure a smooth and successful implementation of the activity, kindly take note of the following **important reminders**:

1. RO and SDOs Information Technology Officer (ITO) participants who will join the activity must be identified by their respective heads of office.
2. SDO JDVP-TVL coordinators shall recommend Public School JDVP coordinators as participants of the activity who must meet the following criteria:
 - a. Should be knowledgeable in operating computers, applications, or any other software.
 - b. Should be willing to share and impart knowledge to others.
3. All participants are **required** to bring a functional laptop and extension cord for use during the activities, outputs and breakout sessions.
