1. We are pleased to announce the conduct of Advanced Training Course for Leaders of Adults with Davao del Norte Council as host.

2. Hereunder are the details of the training course for your information and guidance.

A. Courses:

a.1 ADVANCED TRAINING COURSE FOR LEADERS OF ADULTS

Dec. 02-07, 2025

Samal Family Garden Beach Resort, IGACOS

B. Qualifications for admission:

- Must be currently registered as Institutional Head or Institutional Representative.
- Must be physically fit as certified by a licensed physician.

C. Registration Fee. An amount of Six Thousand Five Hundred Pesos (P 6,500.00) shall be collected each participant, to cover accommodation, meals for the duration of the course, training materials, handouts and other incidental expenses, and must be paid in cash. The amount is chargeable against MOOE or other local funds available subject to the accounting rules and regulations.

D. Reservation Fee. A non-refundable but transferable reservation fee of Two Thousand Five Hundred Pesos (P 2,500.00) shall be charged each participant to be paid on or before November 24, 2025. The remaining amount shall be paid upon registration at the training venue.

E. Deadline of Submission: The attached Application to Attend must be supported with the duly accomplished Medical Examination Form. Said documents shall be endorsed by the Council Scout Executive and Council Training Commissioner and must reach Regional Office 20 days before the start of the said course.

F. Transportation Expenses: Transportation and other miscellaneous expenses incurred before the start of the course shall be borne by the participants or council from point of origin to the course venue.

G. What to bring: Participants must bring along with them the following items:

- Two pieces of recent photo ID (1 x 1) Type "A" uniform
- At least two (2) sets of type "A" uniform.
