



FOCUS GROUP DISCUSSION (FGD) (Youth Stakeholders)

Identified Provinces for Qualitative Data Gathering
With 6 to 8 participants per group / province

Davao Oriental
Davao de Oro
Davao del Norte
Davao City

Criteria for Inclusion

1. **Age Group:** Adolescents aged 10 to 19 years old residing in the Davao region.
2. **Current Engagement with Teen Centers:** Must have accessed or utilized services from a teen center (community-based, school-based, or hospital facility-based) within the last 6 months.
3. **Diverse Representation:** Participants must be selected from various cities/municipalities within the Davao region. Ensure diversity in terms of gender, socio-economic background, and educational attainment.
4. **Willingness to Participate:** Must voluntarily agree to participate in the FGD and provide informed consent (and parental consent for minors aged below 18).
5. **Communication Skills:** Must be willing and able to articulate and share experiences, opinions, and feedback related to teen center services.
6. **Availability:** Must be available for the scheduled online FGD session (approximately 1 to 1.5 hours).

General Instructions

1. Introduction

- Greet all participants warmly and introduce yourself and the research team.
- Explain the purpose of the FGD: *"We are conducting this discussion to understand the experiences, challenges, and perspectives of young people regarding teen centers in the Davao region."*
- Assure participants that their responses will remain confidential and used solely for research purposes.

2. Consent

- Distribute and collect signed informed consent forms.
- For participants below 18, ensure that parental/guardian consent has been secured beforehand.

3. Ground Rules

- *Respect each other's opinions.*
- *One person speaks at a time.*
- *No right or wrong answers – we value all viewpoints.*
- *What is shared here stays here (confidentiality).*
- *Feel free to speak in the language you are most comfortable with (Cebuano, Tagalog, English).*

4. Duration and Format

- Inform participants that the discussion will take approximately 1.5 to 2 hours with short breaks if needed.
- Let them know that the session will be recorded (audio/video) for transcription purposes, with their consent.

5. Participation Guidelines

- Encourage everyone to participate actively but respect their choice if they prefer to pass on certain questions.
- Use a round-robin method at times, but allow open discussion as well.
- Clarify that they can leave the discussion at any time if they feel uncomfortable.

6. Confidentiality

- Reiterate that no names will be included in the final report, and their identities will be protected.

7. FGD Flow

- Begin with ice-breaker questions to make participants comfortable.
- Proceed through the pre-prepared questions under each research variable.
- Allow time for follow-up questions and deeper discussions where necessary.

FGD Guide

A. Teenage Life Obstacles and Challenges

1. What are the most common challenges you face as a teenager living in the Davao region?
2. Can you share any specific experiences where you felt overwhelmed or stressed as a teenager?
3. How do you think social media and technology impact your mental health and well-being?
4. What are some risks or dangers (e.g., substance abuse, early pregnancy, peer pressure) that you or your peers have encountered?
5. How does financial instability or poverty affect your life and choices as a teenager?
6. What challenges do you face when it comes to relationships, whether with family, friends, or romantic partners?
7. If you could change one thing about being a teenager in your community, what would it be and why?

B. Coping Mechanisms and Strategies

1. When faced with stress or problems, what are some things you do to cope or manage your emotions?
2. Who do you usually turn to for support when you are facing difficulties? Why?
3. Can you share any personal strategies that help you deal with academic pressure or family expectations?
4. Have you ever participated in programs, workshops, or counseling offered by teen centers or other organizations to help cope with challenges?
If so, how was your experience?
5. Do you find talking to friends or peers helpful when you are going through tough times?
Why or why not?
6. What are some unhealthy coping mechanisms you have seen among your peers, and how do you avoid them?
7. How do you balance school, personal life, and other responsibilities when things get overwhelming?
8. What advice would you give to other teenagers struggling with similar challenges?

C. Perceptions and Attitudes Towards Teen Centers

1. When you hear the term 'teen center,' what comes to your mind?
How would you describe a teen center in your own words?
2. Have you ever used the services of a teen center?
If yes, what motivated you to seek their help or services?
3. What do you think are the most valuable services that teen centers can provide to young people like you?
4. Do you believe teen centers are accessible and welcoming to all youth? Why or why not?
5. What are some concerns or hesitations you or your peers might have about going to a teen center?
6. How do you feel about the staff and personnel at teen centers? Are they approachable and helpful?
7. Do you think teen centers adequately address the needs of youth in your community? Why or why not?
8. In your opinion, how do teen centers contribute to your mental health, well-being, and overall development?
9. What changes would you like to see in the services or operations of teen centers to make them more effective?
10. If you were to recommend a teen center to a friend, what reasons would you give for them to go?

D. Recommendations

1. What additional services or programs would you like teen centers to offer for youth like you?
2. How can teen centers improve their outreach and communication to make more teenagers aware of their services?
3. What kind of environment do you think a teen center should provide to make youth feel safe, comfortable, and supported?
4. How can teen centers better support teenagers facing mental health challenges or personal crises?
5. What specific suggestions do you have for making teen centers more youth-friendly and inclusive?
6. How can teen centers involve youth more in the planning and implementation of their programs?
7. What role do you think technology and social media should play in teen center services?
8. How can teen centers collaborate with schools, parents, and communities to provide better support for teenagers?
9. What improvements in facilities or resources would you like to see in your local teen center?
10. If you could give one message to policymakers and local leaders about teen centers, what would it be?
