

1. Pursuant to Section 43 of Article IV of R.A. No. 9165, otherwise known as "Comprehensive Dangerous Drugs Act of 2002", the Department of Education reiterates its support in the institutionalization of National Drug Education Program (NDEP) with the school head fully responsible for the effective implementation on its five components.
2. Anent to this, it is requested that the Schools Division Superintendents, SGOD Chief Education Supervisors, Regional/SDO Focal Persons on National Drug Education Program and Barkada Kontra Bisyo, and identified participants from the recipient SDOs and schools (Annex) attend the Regional Kick-Off on the Implementation of Barkada Kontra Bisyo Program and Orientation on the Pilot Implementation of Project ESTORYA on **November 21 - 22, 2025** at **Sunny Point Hotel**. This activity is in partnership with JJ Valderrama Behavioral and Management Center.
3. Schools must use the Automated Class and Teacher Scheduler (ACTS) as per Regional Memorandum No. 025, s. 2023, titled Regional Policy Guidelines in the Substitution of Classes. Learner-leaders who will be participating in the activity must be on alternative delivery modality scheme to comply requirements. Consent from the parents and assent shall be secured for the participation of learners.
4. Further, identified participants and members of the working committee shall be entitled to service credits in accordance with DepEd Order No. 53, s. 2003, entitled Updated Guidelines on the Grant of Vacation Service Credits to teachers. Non-teaching personnel shall be given Compensatory Time-Off (CTO) per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2024 on Non-Monetary Renumeration for Overtime Service Rendered.
5. Travelling and other incidental expenses shall be charged against local funds while venue, meals and accommodation shall be covered by the downloaded Program Support Funds, subject to the usual accounting and auditing rules and regulations.
6. Immediate and wide dissemination of this Memorandum is desired.
